Applicant shall assume full responsibility for the conduct of all persons in attendance at activity for which permit has been granted, and applicant shall be responsible for all damage to the grounds, buildings and facilities of the society.

The society shall not be held responsible for loss or theft of any personal property or damage to motor vehicles.

Applicant agrees to be subject to all conditions, rules and regulations of the Society pertaining to its grounds and the use thereof.

Application must be completed and returned to the Fair Manager thirty (30) days prior to the requested date for use.

The society reserves the right to reject any application and to revoke any permit granted to violation of conditions, rules and regulations.

Applicant is to provide the society with proof of no less than \$1,000,000 in liability insurance no fewer than 30 days prior to the event.
